- (2) To oversee the University's governance of SPCEPs, and to identify the priorities for quality assurance (QA) policy change that supports the long-term development of SPCEPs.
- (3) To review proposals for the introduction of SPCEPs leading to CUHK qualifications by academic units in the University, and of programmes jointly organized by the School of Continuing and Professional Studies, The Chinese University of Hong Kong (CUSCS) with overseas institutions leading to non-local qualifications, for recommendation to the Senate APC/Senate, and to endorse proposals on the assignment of HKQF levels and credits of SPCEPs of the University for approval by the Senate APC/Senate.
- (4) To approve the examination results of all SPCEPs leading to CUHK qualifications on behalf of the Senate.
- (5) To formulate and keep under review strategies for the offering of SPCEPs by academic units in the University, and to discharge such other duties related to the offering of SPCEPs as may be assigned by the Vice-Chancellor from time to time.

- (5) To identify appropriate incentives for teaching and learning enhancement, propose related policies to the University's Administrative and Planning Committee and advise the Resource Allocation Committee on resource allocation in parallel with these initiatives.

- (6) To enhance the University's Education Quality Work (EQW) as a whole bypromoting the use of student feedback as a source of information not only on teaching performance, but also on student learning outcomes.
- (7) To formulate appropriate monitoring procedures that focus on students' learning outcomes.
- (8) To determine ways to optimize the expertise in the Centre for Learning Enhancement And Research (CLEAR) in order to achieve these enumeratedgoals.

- (b) recommend to the Senate for the award of Bachelor's degrees; and
- (c) consider and approve the lists of candidates for the award of a diploma at or below the first degree level.
