Campus Master Planning (CMP): Stage 2 Stakeholder Engagement Activities

Following the release of the CMP Stage 1 Stakeholder Engagement Report, the CMP Consultant will present to University Members the Conceptual Planning Proposal later this month. The document will include the Consultant's Planning Visions for 2021 and 6 Key Planning Issues, namely, Enhancement of College Life, Venues for Academic & Recreational Activities, Pedestrian Friendly Campus, Campus Landscape, A Sustainable Campus, and Conservation of Places with Cultural Significance. These 6 Key Planning Issues address the views gathered from the Stage 1 consultation effort and findings arising from the professional team's detailed study of the CUHK campus. The document will soon be uploaded on the CMP website. Poster display boards highlighting the 6 Key Planning Issues will also be exhibited on a few sites on campus.

- started the Stage 1 CMP Study;
- conducted consultation among stakeholder groups of the University and launched a series of activities gathering detailed information;
- released the Stage 1 Stakeholder Engagement Report; and
- completed the drafting of the Conceptual Planning Proposal.

The Consultant considers the valuable information collected in Stage 1 Stakeholder Engagement very useful in establishing concepts and directions of the conceptual CMP and they look forward very much to continuing communication with stakeholders.
