Among the cosmos of ancient Chinese texts, it is well known that the Thirteen Classics are looked upon as of the greatest importance to the sinologists. However, most of the extant editions of the Pre-Han and Han traditional texts, including those of the Tang and Song dynasties, are, as a rule, not free from corruption and differ significantly from their original state in the Pre-Han and Han periods. If an accurate collection of all the citations from these thirteen works found in Pre-Han and Han traditional texts could be restored, research would be greatly facilitated. In view of this, the researchers put forward "A Proposal of a complete study of the numerous citations from the Thirteen Classics Found in Pre-Han and Han Traditional Texts". The Project was divided into two phases and was granted by the Research Grants council respectively. The long-term significance of the project is to compile a complete collection of the citations from the Thirteen Classics in Pre-Han and Han traditional texts. Also the variant readings found in these citations are beneficial to further research. The researchers hope to correct textual mistakes by making a comparative study between these earliest citations and the extant versions. In addition, they can make an analysis of the variant readings found from these citations. All these will certainty enable us to get closer to the original texts as they were in the Pre-Han and Han periods.

近年,香港詞語的研究成為方言詞研究的重點之一,但研究只限於羅列材料。香港作為珠江三角 洲的主要城市,以經濟文化較高的優勢,香港詞 匯在粵語區的滲透擴散是很自然的事,如能以香 港粵語詞匯爲主,調查這些詞語在其他粵語區使 用的情況,是饒有意義的。

參與本計劃的,除了本系專門研究粵語的教授 外,還有美國華盛頓大學的粵語專家。研究方法 是:

- (一)將初步設計的粵語詞匯表進行分析、整理,設計出一個能顯示香港語言特色的詞表,作 爲調查的基礎。
- (二)選定調查點進行調查。在粵語區選取三至 四個城市作爲研究對象,派出調查員調查香港詞 匯對那些城市滲透使用的現象。
- (三)把調查所得的材料輸入電腦,語料可作詞 匯表出版,另就調查數據進行分析,撰寫論文。 (AL00379)

香港新界的面積 984.74 平方公里,有客、粤、閩 三種系屬不同的方言,並非純粹的廣州腔粤方言 區,1998 年對新界六百多條村初步的調查,旨在 了解都市化前這些村的原居民所採用的方言,結 果是客家村 359 個,佔 57%, 圍頭村(屬粤語) 167 個,佔 26.5%,蛋家村 33 個,佔 5.2%,福 老村 5 個, 佔 0.8%, 混合村 66 個, 佔 10.5%。 這個調查只核對一些語言材料,並對七個點的方 言記錄了約 200 個字的讀音和五十個常用詞的用 法。本計劃在上述調查的基礎上,選取更多的方 言點,記錄更多的語言資料,編寫成《新界方言 調查報告》: (包括 10 個方言點,調查 2000 個 單字,2000 餘個詞語及語法句,並加分析)。並 繪制《新界方言地圖集》: (包括 100 個方言 村,50 個單字,30 個詞條,繪成超過 80 幅方言 地圖)。

The theme of this research is to discuss how the Wu kingdom (222-265) mobilized and gained enough strength, in both human and economic resources, in order to resist the unification by the north during the early third century China. It is interesting to historians that the Wu rulers introduced and enforced a complicated administration system to the lowest stratum of the Wu society where minorities, powerful families and various social groups always defied government supervision. The researcher will place great emphasis on recent evidence excavated at Zoumalou in Changsha, that help to solve the puzzle of how the Wu kingdom controlled people, how the kingdom collected regional resources, and how the kingdom wiped out the power of the local magnates. This proposal is a pilot study of a large project on the social and political development of the Wu kingdom. (AL00476)

This project will explore Chinese diaspora literature in America from the perspective of cross-cultural studies. A close examination of a broad range of literary works produced by Chinese diaspora writers will be supported by in-depth study of theoretic issues such as the concept of nation, homeland, cultural roots, language, and confusion of identity. The significance of this project goes beyond the traditional boundary of national literature studies, because the investigation of diaspora literature demands and rewards new approaches that would expand the field of literary studies by embracing cross-cultural and transnational explorations. Since mutual permeability among different cultures is getting increasingly noticeable in the era of globalization, the researchers need urgently to investigate the consequence of cross-cultural interaction upon the formation and development of Chinese diaspora literature. Therefore, this project is intended to find a new theoretical discourse for

comprehending and analyzing Chinese diaspora literature--a rich tradition of creative writings in the form of fiction, poetry, drama, autobiography and memoir, which has provided extremely valuable materials for us to understand the life and experience of overseas Chinese. (AL00786)

Confucian Learning Through Case-based Writings in the "Xue'an" Format

The aim of this project is to study the relationship between modes of reasoning and the production of Confucian knowledge by a comparative study of Chinese works bearing the common title of xue'anrecord of learning or case of learning - and other works that deal with similar subject matters. Most xue'an-titled works contain selected writings and biographies of individual Confucian scholars, their discussion of Confucian ideas, doctrines and ways of learning, and comments on them by the authors of these books. Modern scholars have usually categorized them as historical writings, objective in their presentation of evidence. The present project re-examines this common notion by studying the background and authorial intent of major xue'an works written between late sixteenth and late eighteenth centuries in comparison with other Confucian knowledge-producing books written in the same period. The inner logic of xue'an works will be searched for a new understanding of their nature and contextual implications. The result is to throw light upon the epistemological positions methodological priorities of the anthologists concerned, which in turn may reflect the intellectual preoccupations of their times in the matter of producing Confucian knowledge. As xue'an works were written by elite Confucianists for elite Confucianists, the project is also a case study for a comparative study of specialist knowledge in Chinese cultural history, which presented itself in other subjects like medicine, law, Buddhist practice, legal storytelling, using the same method of case narrative. Bureaucratic Structure and Social Forces in the Commandery-Prefecture Levels of Han China (220 B.C. to A.D. 220): The Studies of the Bamboo Slips and Wooden Documents Found at Juyan Prefecture and Donghai Commandery

Han dynasty rulers were able to maintain an empire with vast territory over four centuries, with only a few decades of disintegration. They had achieved this by introducing a complex bureaucratic system which had enormous impact on the structure of the society, and fostered strong links with the Through a government and the social forces. systematic study of the political and social governance of two local administrative units, Juyan Prefecture (居延縣), located in Gansu Province (甘 肅省) and Donghai Commandery (東海郡), situated in Jiangsu Province (江蘇省), the researcher will investigate how political networks were formed and social forces took shape during the process of empirebuilding. More specifically, the researcher will examine the interaction between the government and different social groups such as sanlao (三老 elders of lineage), elites (儒生 confucianists), haoqiang(豪疆

magnates) and powerful merchants, who as both political and social actors, helped the rulers to cement the Han empire. The investigation of the relationship between the construction of the Han bureaucratic system and the consolidation of social forces gives better understanding to: (1) the Han experience in building a monolithic empire, (2) the formulation of social identities in terms of relevant social forces, (3) the ideological dominance of a culturally universalistic society, and (4) the integration of various social forces into a major political order. Culture As Destiny? - A Study of the Confucian Experiment in Singapore and the Emergent Global Discourse on Confucianism

The project consists of two parts: First, designed to be a micro-study of the Singapore Confucian Project, it will trace its origin and development in Singapore history, and then it will analyze the political, cultural and social events and policies in the 1980s associated with the Confucian Project. Second, it will assess the impact of Singapore Confucianism on Asia particularly in Chinese societies in connection with the intellectual debates on Confucian revivalism such as "Asian Values", "Culture as Destiny" and the "Neo-Confucian Century". A Comparative Study of Corruption: The Cases of Chang Chu-cheng (1525-1582) and Francis Bacon (1561-1626)

This project proposes to examine the corruption cases of Chang Chu-cheng (1525-1582) and Francis Bacon (1561-1626) in a comparative and interdisciplinary perspective. The research involves scrutiny of the primary and secondary sources on the bribery cases as well as the political and legal settings of these two respective figures. Their thoughts and values in relation to law and moral philosophy pertaining to corruption will also be examined. By incorporating theories and concepts in the fields of legal history, jurisprudence, politics, moral philosophy, and psychology, this study aims to develop an interpretive framework viewing the two cases as empirical

examples of interplay between rationality, legality, morality, and politics. (AL00639)

Norms and the Evolution of Strategy: The Vicissitude of the Ch'ung Military Family in Northern Sung China

As an interdisciplinary project synthesizing the study of strategic culture and history, the proposed research will establish the relevance of strategic culture to the study of Chinese history, by providing a theoretical framework from which to consider normative change within a historical context. The researcher will consider the norm-building process of strategic, military interaction during Northern Sung China, and examine how specific strategic approaches that are normatively affirmed could in turn challenge the Confucian moral constrains in the conduction of foreign affairs, and how the conflict and reconciliation of norms constitute new strategy. The empirical research will be based on a case study on the Ch'ung military family (种氏將門), probably the most important military family of Northern Sung China. Their rise and prosperity during eleventh century China marks a transition of grand strategic preference of the Northern Sung from defense to offense. The study of the gradual deviation from the Confucian/Mencian norms to a realist paradigm and the initiation of external ventures would provide important interpretative data with relevance to the context of international relations as well. Women's Choices and Changing Social Values: A Study of Japanese Unmarried Women in Japan and Abroad

This project explores the experiences of Japanese women who remain unmarried beyond their latetwenties in Japan, Hong Kong and other areas outside of Japan. In the latter half of the 1990s, media attention has focused on the trend in which Japanese women delay marriage or choose not to marry at all. Throughout most of the postwar period, Japanese women tended to marry within a narrow age range in their mid-twenties. The average age of marriage has risen steadily in the postwar period, and in the past decade unprecedented numbers of women in their 30s and 40s have remained unmarried. The media represents unmarried women as selfish "parasitic singles" who continue to live with their parents while spending money on personal luxury items. Conservative politicians and journalists blame unmarried women for the decline of the Japanese birth rate and family values. Yet surveys show that

most women would prefer to marry if they could find an appropriate partner. This project contributes to a growing literature that examines how people reflexively shape their lives (Giddens 1991:52, Bruner 1986:12, Battaglia 1995:3) in relation to larger social debates. Through in depth interviews and media analysis, this study examines how women's decisions regarding work, family and marriage reflect expanding opportunities and changing values in Japanese society. The project also considers how women's choices and widespread social anxiety are both shaped by changing social and economic structures which have brought women increased opportunity in an expanding global economy.

Acquisition of Classifiers in Hong Kong Sign Language by Deaf Children

This project aims to examine the development of classifiers in Hong Kong Sign Language (HKSL) by deaf children. Previous research has shown that classifiers in signed language are represented by handshape. This sublexical unit becomes a bound morpheme and combines with the movement morpheme to form a characteristic construction among signed languages - classifier predicates. Tang (2000a & b) demonstrates that HKSL classifiers display properties of semantic universals such as animacy, humanness, size and shape. Similar to other signed languages, they are verbal rather than nominal and enter into different types of predicate constructions. Classifiers have been categorized into three types. The semantic classifiers have been intensively studied with respect to verbs of motion and location. The size and shape specifiers are associated with adjectival predicates, and the instrument classifiers into enter causative constructions in signed language.

The current project aims to examine how deaf children acquiring HKSL as first language develop the knowledge of classifiers. This involves an analysis of:

- (1) the process in which they associate classifiers with the different forms of handshape;
- (2) how the different forms of handshape reflect the child's knowledge of semantic characteristics;
- (3) how the three different types of classifiers emerge in the grammar of classifier predicates; and
- (4) the development of the movement root in the classifier predicates.

This research project adopts a cross-sectional approach, involving deaf children aged between 3 and 10 who develop HKSL since birth from deaf parents. A picture description task and an interactive language game will be used and the deaf children's performance will be video-taped. The data will be transcribed according to the CHILDES' format adapted for analyzing signed language acquisition data (Slobin and Hoiting 2000). The data will be compared with the acquisition of classifiers by child acquirers of American Sign Language and the Sign Language of the Netherlands. Also, data from the hearing children from a spoken classifying language background like Cantonese and Mandarin will also be adopted in order to verify the universal issues of language acquisition.

Minority Languages in Yunnan

The proposed study aims to conduct a linguistic investigation into three of the representative languages spoken by the minority groups in Yunnan, namely Yi, Bai and Jingpo. The study looks at the major grammatical areas of these languages such as word order and argument structure (i.e. properties of verbs and their arguments). The method of investigation involves fieldwork and informant elicitation. Extensive and systematic organization of the language data is called for. On the basis of descriptive data and generalizations, the researchers proceed to analyze aspects of the grammar in line with current linguistic frameworks, addressing issues of universality and variation. The findings of the project will enrich our knowledge of the linguistic structure of the minority languages and inform linguists working in both diachronic and synchronic traditions. Abstract Concept Formation in the Chinese Context

This project aims at outlining the various mechanisms of abstract concept formation in the Chinese language, spoken (linguistic) as well as written. At the outset, the notion "abstract concept" will be defined, both from a linguistic and a philosophical point of view. A historical review of the problem will be sketched to provide leads for subsequent discussion. The next thing to be done is the identification and classification of various abstract concepts as can be found in the Chinese language. Alongside the classification of abstract concept in Chinese, an attempt will be made to explain through what mechanisms these various abstract concepts can be formed or constituted. In explaining the various mechanisms of abstract concept formation in Chinese, traditional Chinese lingusitic terminologies and theories will be treated in the first place. To render such theories and terminologies intelligible in a broader context, the same abstract conceptual structures and mechanisms will be explained with Western linguistic theoretical models. In so doing, the works of philosophers and linguists such as Plato, Leibniz, herder, Wilhelm von Humboldt, Saussure, Jakobson, Benveniste, Lakoff, Fillmore etc. will be taken into account. By the completion of the project, a balance sheet will be drafted to report on the research as described above. Special effort will be made to throw light on the idiosyncrasies, if any, of abstract concept formation in Chinese, as compared with that in the other languages. Discussion will also focus on the question, to what extent the problem of abstract concept formation is important for the understanding of the Chinese mind and culture. Though literally a research project on an "abstract" issue, such research will arguably affect educational policies concerning the teaching and learning of the Chinese language in the future. Concept and Practice of Humanities Computing: The Integration of XML into a New Working Model

In the world of Internet, it is generally considered that Hyper Text Markup Language (HTML), the lingua franca of web page construction, is subject to serious limitations. Being originally designed for online document presentation, HTML allows little freedom and minimal flexibility for the description of complex information. From the users' point of view, this limitation might not be a matter of immediate concern, but from the point of view of web page developers, this inherent shortcoming could become a hurdle for future development. This applies inter alia to humanities computing research, where the need to deal with information with different degrees of complexity is obvious. To overcome the limits of HTML, the eXtensible Markup Language (XML) has been developed by the World Wide Web Consortium (W3C). XML is a simplified version of the Standard Generalized Markup Language (SGML) which allows the self-definition of markup, which in turn is essential for the effective handling of complex data While much more flexible than the original SGML, XML is suitable for WWW implementation. With the widespread dissemination of cyber culture, WWW users will become increasingly demanding. They will be satisfied no longer with the mere presence or abundance of information, but only with the quality with which such information is presented. Having ourselves developed a series of humanities web-pages with general recognition, we see in the introduction of XML standard the possibility of developing a new working model of textual information processing. It is expected that this proactive awareness and use of XML will lead to an overall improvement of our work in humanities computational research. (CU00304)

Politics, History and Critique of Modernity in Heidegger's Philosophy

Martin Heidegger (1889-1976) has been and continuous to one of the most influential and thought provoking contemporary thinkers. Since the late 1980s one of the focal points of Heidegger studies is developed around the relationship between Heidegger's philosophy and his political participation. Among the most frequently asked questions are:

Is Heidegger's support of Nazi Germany a merely historical accident or does it have an intrinsic bearing with his own philosophical thought? Does Heidegger's existential ontology expressed in his opus magnum *Sein und Zeit* carry within itself an implicit but more or less well-defined political orientation? Does the latter have any internal relationship with his vision of History in general and

his critique of Modernity in particular? In what sense Heidegger's understanding of politics, history and modernity can contribute to the reformulation of political philosophy and philosophy of history at the dawn of Postmodernity?

The present project will probably be one of the first in its kind among scholars of Chinese origin to contribute to the above problematic. (AL20005)

The rise of liberalism in the West was mainly due to the religious wars in the 17th century, which followed the Reformation. Reformation gave rise to modern pluralism, which maintains that there is no objectively correct answer regarding the conception of good life. All these are closely related to what Weber calls the two characteristics of modernity, namely, the disenchantment of the world and the instrumentalization of rationality. The project investigates issues involved in these areas from a philosophical perspective. (AL00845)

Two-dimensionalism and Theory of Reference

As a framework for investigating the relationship between context and content, two-dimensionalism has its roots in Saul Kripke's 'Naming and Necessity' and David Kaplan's 'Demonstratives'. developed in such works as Robert Stalnaker's 'Assertion' (1978) and Marin Davies and I. L. Humberstone's 'Two Notions of Necessity' (1980). Two recent applications of the framework, found in David Chalmers' The Conscious Mind (Oxford University Press 1996) and Frank Jackson's From Metaphysics to Ethics (Oxford University Press 1998), have shown that the framework provides a resource for addressing not only the theory of reference, but also for tackling some important questions in metaphysics and the philosophy of mind. This study critically examines the version of twodimensionalism developed by Jackson and that by The researcher's view is that both Chalmers accounts are susceptible to what he has called 'the two-propositions problem'. Some results of this study are reported in the paper 'Two-dimensionalism, Context and Reference', presented in The Second Barcelona Workshop on Issues in the Theory of Reference: Two Dimensionalism (June 2001, Spain). A Ritual Approach to the Local Charismatic Christianity - with Special Reference to the Phenomena of Glossolalia and "Slain in the Spirit"

How can a better understanding of the local charismatic Christianity be facilitated? Should we understand it through the lens of its rituals or that of its theologies? How can we interpret it in religious terms without losing sight of the fact that it can be legitimately taken as a social-scientific phenomenon? How should we explain its growing cross-denominational influence among the local Christian circles and the formation of its relatively strong but cross-denominational identities? These are the guiding questions for this proposed research, and the researcher is going to suggest that they be best dealt with by means of a ritual study.

It is scholarly agreed that the most characteristic features of the charismatic Christianity are its mysterious form of communication and encountering with God - known as *glossolalia* and *slain in the Spirit*. These phenomena are therefore reasonably good windows through which we see the charismatic Christianity.

Glossolalia and Slain in the Spirit as religious experience and practices have long been researched by researchers from diverse disciplines. proposed research, however, will show that past researches have - more often than not - been reductionistic. Theological investigations into this area tend to commit a kind of theological reductionism given rise by a theoretical inclination for taking religious ritual as secondary expression of some beliefs. Social-scientific studies could also be reductionistic by taking ritual as eminently social. This proposed research will try to avoid both kinds of reductionism by offering thick descriptions of the phenomena in both the languages of the insiders and ritologists. The researcher will try to articulate the religiosity of the phenomena. Besides, by relying on the insights provided by the ritual theories as developed by Ronald L. Grimes, Victor Turner and Catherine Bell, the researcher will articulate how the ritual behavior and the various power relationships within the ritual practices are coordinated, and how the religious and community identities are negotiated through the ritual processes. The main research methods are participant observation ethnographical interviewing. (AL00838)

A Study of Nahm Mouh (喃嘸) Daoist Tradition in Hong Kong

In Hong Kong, Nahm mouh Daoist priests (喃嘸道 are individually hired and paid to provide Daoist ritual services such as funeral rites (打齋) and rites of offerings (禮斗). These are two different types of ritual activities separately called as the "white affairs" (白事) and "red affairs" (紅 事). This research project is first to focus on the study of nahm mouh funeral rite that aims at the salvation of the dead. First is the preliminary reconstruction of the history of *nahm mouh* tradition in Hong Kong as well as its link to the Cantonese nahm mouh tradition, which has already been found in the late Qing period. Second, by means of oral interviews, the researcher will investigate the genealogy and history of some significant nahm mouh families in Hong Kong. Third, the ritual processes and structure of the funeral rites performed by the *nahm mouh sin-sang* will be studied. In this part of fieldwork research, the researcher will observe their ritual performance, collect and study their ritual Finally, there are about fifteen to manuscripts. twenty Daoist Halls (道院) presently opened by nahm mouh sin-sang in Hong Kong. In these Daoist Halls, professional services of Daoist funeral rites are provided for the families of the dead. The researcher will reconstruct the history, network and activities of some representative Daoist Hall. (AL00879)

Localism and Globalism in Christian-Confucian Dialogue

In recent years, Christian-Confucian dialogue has become an international phenomenon rather than just a dialogue restricted to the Chinese local context. The dialogue at the global level, with regard to its presupposition, concern and perspective, is significantly different from the dialogue in the local Chinese context. In other words, there are two paradigms of contemporary Christian-Confucian dialogue at play - one local, one global. At the moment, the interaction between the two is minimal. While many Chinese scholars take no notice of the global dialogue, many Western participants of the international dialogue disregard the issues raised at

the local level. The aim of the proposed research is to introduce the issues raised in the Chinese context to the international circle and to make known the results of the global dialogue to the Chinese speaking world. It will further argue that the two paradigms may complement each other. The local issues may enrich the global dialogue and in return the global dialogue may cast new light to the discussion of the local issues. At last, the achievement and distinctiveness of the local as well as the international Confucian-Christian dialogue will be viewed in the global context of inter-religious dialogue, including in comparison with other interfaith dialogues, e.g. Buddhist-Christian dialogue. "Love is as Strong as Death" - A Study of Love Poems and Songs of Laments in the Ancient Hebrew and Chinese Classics

Christianity and local Religions in Tai-an Region, Shandong Province

The present research project is part of a long term project on "Christianity and Social Changes in Contemporary China". It is an attempt to study the interplay between Christianity and local Chinese religions in Tai-an Region in the past hundred years and will focus especially on the period since the adoption of open policy in China by the early 1980s.

Tai-an region is chosen as a case study because: Firstly, Tai-an is a unique region surrounding the mysterious, sacred Tai Mountain (泰山), which has long been an active religious center for Buddhism. Taoism and other folk religions in China. The Tai Mountain had brought about much spiritual resources for the folk people which are still flourishing in the whole region today. Secondly, Tai-an is adjacent to Qufu (曲阜) which is the birth place of Confucius and hence becomes another sacred place for Confucianism. Thirdly, it has been one of top five counties in Shandong province where Christianity reached spectacular development since the modern Hence, the researchers will attempt to time investigate into the inter-religious encounters and exchange of ideas and practices among Christianity, Buddhism, Confucianism, Taoism and other folk religions found in this Tai-an region. A Study of the Ming Novel and Religion

This project will take a group of Ming novels, the "God-Demon" Novels, as the object of study. Taoism in the Ming was further popularized, and permeated various aspects of the society. The Ming novel, as popular literature, witnessed this penetrating influence in relation to the Taoist thought, practice, institution, and symbolism. This project will review the religious nature of the literary form and genre through production, dissemination and cultural use from the ritual perspective. Moreover, this study will explore how these novels exerted an influence on the reader community in the daily life.

The study will begin with an examination of the relationship between Ming novels and Taoist scriptures. Secondly, by surveying the printing and publishing of these novels, the study will help us understand the process of the popularization of Taoism in the popular narratives which functioned to disseminate Taoism, bridged the religious institution and secular community, and were regarded as the daily religious texts. Thirdly, this study will emphasize the ritual function of these novels in that in addition to disseminating Taoist thought, the novels also instructed readers in their religious behaviors, were used as the ritual manuals for the Taoist practitioners in practice, and even became parts of the Taoist ritual writings. Finally, the study will demonstrate that the reading and spreading of these novels was not only a literary entertainment, but also a religious behavior because the reading of these novels represented a religious piousness, and

the spreading of the stories in the novels constituted charities. (AL00522)

Chinese Christian Women in Hong Kong

Christian women constitute a highly interesting group in Hong Kong because of the latter's past hundredyear peculiar political setup. However, including the one on the Western women in early Colonial period, there are only a few historical or sociopolitical studies about them. With regard to the activities of Chinese Christian women in Hong Kong, almost nothing is written on them except the initial works done by Carl T. Smith. This situation is most unfortunate for two reasons. First, Chinese Christian women constituted a major force among early women's movement in Hong Kong. Until recently, Chinese Christian women as a collective are highly active in some of the most controversial local social and political debate. Second, from the beginning, Chinese Christian women's activities have always been set against an unique background of Hong Kong being a colony of a Christian nation (until 1997) and yet its population remained predominantly Chinese. Like all of the other Hong Kong Christians, they have been placed in a position between striving to be faithful to a religion of the colonizer while maintaining loyalty toward their nation during a century when China underwent series of political turbulence. For those women who are conscious of it, the struggle between dual identities have been doubled if we take into the consideration of women's assigned role and status in Chinese society. Consequently, a study of the activities of Hong Kong Christian women could lead us to an understanding of how the question of gender has entangled with the antagonistic rhetoric of colonialism and nationalism in the history of Hong Kong. A Study on the Working Condition of Male and Female Church Workers in Hong Kong

In view of increasing public awareness in the need for gender equity in Hong Kong, more Christian churches have taken more progressive measures in appointing women to various administrative or executive positions including ordained priesthood that were formerly closed to them. However, according to some previous surveys done by "Christian Times" and the Church Renewal Movement, there are still not a small number of women being excluded from preaching at the pulpit, administering holy communion, or taking part in the top administrative and/or executive responsibilites. There are still churches who declare openly that they have difficulties accepting women into the ordained ministry. This posts difficulties for women seeking gender equity within the context of the Christian community, despite the general acceptance of direction in society.

According to a survey of 1999, women take up about sixty percent of all paid positions in the church including both full time and part time workers. However, women who work on "top" levels of the Church including both ordained or not amount to only less than 10%. The goal of this study is therefore to find out the general working conditions of church workers in Hong Kong and to draw a comparison between men and women workers. This study will include a survey of the workers' opinion on job satisfaction, fairness of the system and whether gender stereotypes, exist and affect their work. The preliminary result will be further reviewed in focus groups and a deep analysis of Churches' practice in gender equity will be attempted. (BS00845)

Machine Translation of Procedural Texts: As Demonstrated by *TransRecipe*

This project intends to study the general issues relating to the construction of a fully automatic machine translation system for procedural texts through the demonstration of a domain-specific system known as TransRecipe. TransRecipe is a fully automatic translation system for Chinese cookbooks based on the transfer model which combines the corpus-based, example-based, patternbased, and rule-based approaches. With a lexical database of around 20,000 entries of Chinese food and drink, a general dictionary of around 2,000 frequently used expressions, a database of 200 examples and a total of 700 global parsing rules, the system will be able to automatically translate a recipe from Chinese into English within seconds without any pre-processing or post-editing.

This project sets out to achieve several goals in the field of machine translation which have not yet been realized by other Chinese-English translation systems already in the market. Firstly, it will be the worldfirst fully automatic translation system specially designed for the rendition of Chinese recipes into English. Secondly, it applies a large number of translation methods in the parsing stage in order to produce a high-quality output that is translationally acceptable. Thirdly, it serves as a pilot system to illustrate the mechanical translation of procedural texts, the experience of which can be applied to the translation of instruction manuals, financial documents and scientific writings. The project aims at studying the translation activities undertaken by members of major literary societies in Modern China, 1919-49, with special reference to the relationship between such activities and the different ideologies upheld by these societies. Its framework comes mainly from contemporary translation theories, which see translation as a purposeful activity to promote or to attack certain ideologies. It is a literary studies project as much as a translation studies project, since most of the targets of research will be literary ones such as writers and literary creations. Further, the socio-political elements will also be a major focus because almost all literary groups of modern China had a deep commitment to social and political issues.

The output will be two books plus a webpage. The first book is a monograph devoted to the careful analysis of the various issues mentioned above. It will be the first of its kind. The second will be a sourcebook of materials on modern Chinese translation that researchers in translation studies and literary studies of modern China will find useful. A webpage will be prepared to facilitate exchanges with scholars from all over the world. It will be updated regularly throughout the research period and after the project is completed. (CU00315)
