- 1. The form must be filled in English.
- 2. For item A, please refer to appendix 1 for the type of residence. Please note that the floor area is calculated in square feet (1 sq.m = 10.764 sq. ft) and please provide the supporting documents showing the calculation of total living area. When total living area is not available, it will be calculated by 90% of the saleable area.
- 3. For item B, please refer to appendix 4.
- 4. For applicants applying for "special quota" in item C, please refer to appendix 3 and select a proper category. For other applicants, please select "Not applicable".
- 5. Applicants are required to print the submitted online application form and submit the form in person with <u>original and copies</u> of proof of residential address and area to Shaw College information counter at Wen Lan Tang LG1 <u>from 20 August (9 a.m.) to 25 August (12 noon) within office hour (Monday to Friday, 9:00-17:00).</u>

Documents to be submitted include:

- A. <u>Original and Copies</u> of applicant's residential address proof e.g. notification letter or letters issued by the Government/ University or admission forms issued by Hong Kong Examinations and Assessment Authority
- B. Original and Copies of residential address proof of all members living with the applicant (for at least 6 months over the past year), e.g. school documents, notification of voter registration, tax return form, public rental housing tenancy agreement (only accept the signed within the recent two years), old age allowance documents, demand for payment of rates, invoices/ receipts from property management companies, electricity, water or gas (mobile telephone bills, statements from financial institutions and letters from Leisure and Cultural Services Department and Hong Kong Public Libraries are not applicable). Original copy of the relevant documents must be provided for verification. Although applicants may choose to make a declaration at the Home Affairs Department stating their residential address, full name of members living with the applicant (for at least 6 months over the past year), Identity Card number and residential area if they could not provide the above-mentioned document, the applicants concerned are still requested to provide sufficient evidence to show why they cannot provide such document.
- C. <u>Copy</u> of proof of residential area e.g. letter of proof by Estate Offices of Housing Department. For private properties, proof from Land Office, floor plan on agreements for sale and purchase of building units or sales brochure can be used (state clearly how usable floor area is calculated).
- D. The Selection Committee will give scores based on the above documents. The Committee reserves the right to request declaration by applicants and members living with the applicants.
- E. Should applicants fail to present proof required, scores of related parts will not be counted. Original copy of proof must be submitted for verification.
- F. If health condition is listed as a reason of application, only proof from doctors of the University Health Service or The Hospital Authority in Hong Kong will be considered.
- G. Should applicants' reported addresses are different from those in the record of the Registration and Examinations Section, and applicants fail to provide valid explanations, their applications will NOT be considered.
- H. Information submitted by the applicants must be true to the best of their knowledge. A strict assessment of all information provided will be carried out. Cases in doubt may be verified by home visit. The College will continue

relevant verification work after residents moving in. Any change of information should be reported in writing to wardens. False report or forged documents, if found, residents' right of residence will be immediately deprived. The case will also be referred to the College Disciplinary Committee for consideration of further actions. Applicants' future application for hostel places will NOT be considered.

- I. Applicants who do not live with parents should provide **detailed explanation in writing** and attach supporting document(s).
- 6. Should applicants fail to present proof required, marks of related parts will not be counted.
