## THE CHINESE UNIVERSITY OF HONG KONG

## Summary Report of the 2nd (2011) Council Meeting (14th June, 2011)

- 1. The Council APPROVED the Budget of the University for 2011-12.
- 2. The Council APPROVED the award of Honorary Degrees at the 70th Congregation of the University to be held on Thursday, 15th December, 2011.
- 3. The Council APPROVED the following appointments/re-appointments:-
  - (a) Professor Hau Kit-tai as Pro-Vice-Chancellor of the University for a period of two years with effect from 1st August, 2011;
  - (b) Professor Dennis K.P. Ng as Associate Pro-Vice-Chancellor for a period of three years with effect from 1st August, 2011;
  - (c) Professor Fung Tung as Associate Pro-Vice-Chancellor for a further period of three years with effect from 1st August, 2011 (re-appointment);
  - (d) Professor Leung Yuen-sang as Head of Chung Chi College for a further period of three years with effect from 1st August, 2011 (re-appointment);
  - (e) Professor Christopher Gane as Dean of the Faculty of Law for a term of five years with effect from September 2011 or as soon as possible thereafter;
  - (f) Professor Wong Wing-shing as Dean of the Graduate School for a further period of three years with effect from 1st September, 2011 (re-appointment); and
  - (g) Professor Dennis K.P. Ng as the University Dean of Students for a further period of three years with effect from 1st August, 2011 (re-appointment).

- 5. The Council NOTED the relocation of the site of C.W. Chu College.
- 6. The Council APPROVED the re-appointment of Mr. Heung Shu-fai as Member of the Distinctive Marks and Ceremonial Dress Committee for a further period of three years from 18th October, 2011.
- 7. The Council APPROVED the re-appointment of Mr. Karl C.L. Kwok as Member of the Terms of Service Committee for a further period of three years from 18th October, 2011.
