## Summary Report of the 1st (2014) Council Meeting (14th January, 2014)

- 1. The Council RECEIVED a report from the Vice-Chancellor on the development and achievements of the University in 2012-13.
- 2. The Council NOTED that there would be further consultation on the amendments to the Statutes of The Chinese University of Hong Kong Ordinance related to Council reorganization.
- 3. The Council RE-APPOINTED Mr. Roger K.H. Luk as Treasurer of the University for a further period of three years from 2nd March, 2014.
- 4. The Council APPROVED the appointment of Honorary Fellows, as recommended by the Honorary Fellowship Committee.
- 5. The Council APPROVED the appointment of Professor Francis K.L. Chan as Dean of the Faculty of Medicine for a term of five years with effect from 1st February, 2014.
- 6. The Council RE-NOMINATED Dr. Anthony Neoh as a Member of the Honorary Degrees Committee for a further period of three years from 1st March, 2014.
- 7. The Council APPROVED the re-appointment of Dr. Raymond P.L. Kwok as Chairman of the Campus Planning and Building Committee for a further period of three years from 2nd March, 2014.
- 8. The Council APPROVED the re-appointment of Dr. William K.L. Fung as a Member of the Terms of Service Committee for a further period of three years from 8th May, 2014.
- 9. The Council APPROVED the re-appointment of the following Council Members as Members of the Committee on Institutional Advancement each for a further period of three years from 15th June, 2014:-

- 10. The Council APPROVED the appointment of Director of School (equivalent to Chairman of Department) and Director of Studies.

- 12. The Council APPROVED the revisions to the Regulations Governing Private Clinical Practice with effect from 1st February, 2014 or thereafter.
- 13. The Council RECEIVED the report on the 1st (2013) meeting of the Audit Committee held on 8th October, 2013.

- 14. The Council APPOINTED/RE-APPOINTED the following Council Members as the Council's representatives on the Boards of Advisers for the appointment of academic and senior administrative staff:-
  - (a) Dr. Thomas H.C. Cheung for a term of three years with effect from 15th January, 2014; and
  - (b) Dr. Anthony Neoh for a further term of three years from 3rd April, 2014.
