The proposed amendments to the *Regulations Governing Undergraduate Medical Studies* (for students admitted to the five-year and to the six-year curricula) with immediate effect were approved.

A report on admission with advanced standing administratively approved by the Registrar and Secretary on behalf of the Senate, in accordance with previous Senate approvals on the exemptions for admission against FYFD quota with advanced standing was noted.

The annual report of 2012-13 from the University Library System was received, and the University Librarian supplemented the submission with a verbal report to the Senate.

The courses recognized by the Faculty of Social Science for exemption for admission against FYFD quota with advanced standing with effect from 2013-14 were approved.

The recommendation to change the assessment outcomes of two general education courses, GEUC2101 "Social Service: Participation and Reflection" and GEUC2102 "Public Affairs: Participation and Reflection", to Pass/Fail with effect from 2014-15 was approved.

The recommendation for the College Masters of the new Colleges to be one of the signatories of degree certificates for graduates of their respective Colleges was approved.

A vote of thank to Professor Xu Yangsheng, who had stepped down from the position of Pro-Vice-Chancellor of the University with effect from 1 August 2013, was recorded for his service to the Senate.

The recommendations of the Financial Affairs Working Group Report, recently released by the University Grants Committee (UGC), which noted the significant increase in the number of self-financed programmes and the cost recovery and cost charging mechanisms to prevent against any cross-subsidy of such programmes by UGC-funded programmes were heard.
